Remove fuel filter housing and take apart to inspect the high pressure regulating valve.  
Find that there is steel filings in the return line screen filter.  
Remove high pressure fuel pump on the back of the head.  
Take high pressure fuel pump apart and inspect.  
Find that the key on the drive gear inside the high pressure fuel pump is broken in pieces.  
Order new pump.
