REASSEMBLED ALL, AND SET OVER HEAD, USING NEW AND REUSABLE HARDWARE, GASKETS, AND SEALS, AS NEEDED. INSTALLED NEW AIR CLEANER, FILTERS, COOLANT, AND ENGINE OIL (SAE50). REPRIMED FUEL SYSTEM AND GOT ENGINE RUNNING, RAN GREAT. STEAM CLEANED ENGINE AREA ONE MORE TIME AND REASSEMBLED ALL HOODS AND SIDES, OF ENGINE COMPARTMENT.
