L WENT TO FIGURE OUT HOW TO OVERRIDE THE STEERING TO BE ABLE TO PUSH IT INSIDE THE SHOP AND IT WAS DEAD. HAD TO GET A 24V CHARGER AND LET IT CHARGE. ONCE I FIGURED OUT HOW TO RUN THE OVERRIDE I WINCH IT INTO THE SHOP. STARTED WITH PULLING THE VALVE COVER AND THEN THE ROCKER SHAFTS, AND INJECTOR HARNESS TO LOOK AND MEASURE FOR A BENT VALVE THE EXHAUST PUSH TUBE ON FIVE WAS THE ONE THAT WAS OFF. DRAINED ALL FLUIDS. REMOVED MUFFLER, DISCONNECTED BATTERY, REMOVED FUEL FILTER ASSEMBLY. FOUND YOU HAD TO PULL TRANSMISSION WITH ENGINE BECAUSE THERE IS NO WAY TO SPLIT THE ENGINE IN CHASSIS. SO THEN REMOVED ALL LINES AND WIRES FROM THE TANK AND FRAME SUPPORT AND PULLED HYDRAULIC PACK. CONTINUE REMOVING HOUSES WHEN I REALIZED I ALSO HAD TO REMOVED THE COOLING PACK TO GET THE TRANS MISSION UP. THEN DISCONNECTED ALL HARNESSES AND LINES AND THEN PULLED THE ENGINE MOVED OUT AND SAT ON THE GROUND.
