Fold - - -

to talk to Perry about the off set plate on the concave frame. Checked over the cone and seen a bunch of pin holes in it.

Talked to Perry and he said to patch up the cone and hard surface the worn out area and repair the offset plate. Cut out the damaged vanes. The cone was paper thin and I had to built it up with two layer of weld and then I laid two layer of hard surface on it. I cut off the worn out piece on the offset plate and I cut a patch panel for it. Welded in the patch panel and hard surfaced it. Installed new vanes and cone hardware that was missing. Had to vacuum top of cone off so I could install cone hardware and vanes hardware.

Ground out the cracks on the C-channel and welded them up. Fabricated reinforcement plates and welded them on the C-channel. Checked the rotor bearing and it had play and it was installed the wrong way and was not getting any grease. Installed new bearing and greased it up. Got forklift and lift the rotor back into place. Pulled the rotor back into the combine with a come alone. Lifted c-channel back into place and tightened all hardware. Installed elephant ears and tightened hardware to spec. Installed new wear bar on the rotor and tightened hardware to spec. Straightened out the top half moon cover because there was only one bolt holding it on and it was bent.

Installed top and bottom half moon covers. Hooked forklift onto the feeder house and lifted it up. Removed hardware on damaged feeder floor. Had a hard time getting it out because panel was bent. Had to straight out a bent part of the floor in behind the one being replaced. Beat the floor

Installed the feeder house back onto to the combine and installed pins, hydraulics, wiring, shields and panels. Re-installed concaves and checked pinch point. Adjusted concave stop bolts. Rechecked and it was good. The bottom sieve was not operating. One of the pins was push out of the connector. The lights under the cab were not working so I cleaned the connections for them and got them working. The only other issue I found was the bottom hydraulic cooler was leaking. There is also a clunking sound when you move forward to reverse sounds like a motor to transmission splines worn.
