FORD IS RECALLING CERTAIN MODEL YEAR 2009 AND 2010 F-150 VEHICLES MANUFACTURED FROM JANUARY 18, 2008, THROUGH NOVEMBER 30, 2009. THE INTERIOR DOOR HANDLE HOUSING EMBOSSEMENT RETAINING THE INTERIOR DOOR HANDLE SPRING MAY FRACTURE DURING NORMAL USAGE RESULTING IN INSUFFICIENT SPRING FORCE TO RETURN THE HANDLE TO THE FULLY STOWED POSITION.

Remedy

FORD MOTOR COMPANY HAS AUTHORIZED YOUR DEALER TO INSPECT THE INTERIOR DOOR HANDLES ON YOUR VEHICLE AND REINFORCE, OR REPLACE, THE HANDLES AS NECESSARY. THIS INSPECTION AND SERVICE MUST BE PERFORMED EVEN IF A DOOR HANDLE ON YOUR
