### **Recall Description**

ENGINE BLOCK HEATER CABLE SPLICE CONNECTORS THAT HAD BEEN INSPECTED IN ACCORDANCE WITH RECALL 18S45 - 18V894 MAY HAVE INADVERTENTLY BECOME DAMAGED DURING THAT SERVICE PROCEDURE. A DAMAGED BLOCK HEATER CABLE CAN CAUSE A RESISTIVE SHORT, INOPERATIVE ENGINE BLOCK HEATER, AND OR TRIPPING OF HOUSEHOLD BREAKERS OR GFCI EQUIPPED OUTLETS WHILE THE VEHICLE IS PARKED AND THE BLOCK HEATER IS PLUGGED IN.

### Remedy

FORD MOTOR COMPANY HAS AUTHORIZED YOUR DEALER TO DISABLE YOUR EXISTING ENGINE BLOCK HEATER CORD. THE DISABLING OF THE CORD WILL BE DONE FREE OF CHARGE PARTS AND LABOR.
