Recall #: N242469160 | Tailgate May Open Unexpectedly Recall Date: 2024 Nov 26

Recall Description

General Motors has decided that a defect which relates to motor vehicle safety exists in certain 2024 model year Chevrolet Silverado Heavy Duty (2500/3500 series) and GMC Sierra Heavy Duty (2500/3500 series) vehicles equipped with power-unlatching tailgates. Under certain conditions water may intrude into these vehicles' tailgates and come into contact with the electronic gate-release switch, potentially causing a short circuit. The gate may inadvertently unlatch while the vehicle is in Park. This is an expansion of NHTSA Recall 24V-060 (GM Recall N232426400).

Remedy

Dealers will replace the exterior touchpad switch assemblies.

Recall Description

General Motors has decided to conduct a Voluntary Emission Recall involving certain 2024 MY Chevrolet Silverado and GMC Sierra vehicles with a 6.6L diesel engine. The Engine Control Module (ECM) may not properly diagnose, may not set Diagnostic Trouble Codes (DTCs), or may not illuminate the Malfunction Indicator Light (Check Engine Light) if certain fault conditions of the Selective Catalyst Reduction (SCR or NOx) catalyst occur.

Remedy

Dealers are to reprogram the ECM and TCM.
