Recall Description

General Motors has decided that a defect which relates to motor vehicle safety exists in certain 2017-2019 model year Chevrolet Silverado 2500/3500 and GMC Sierra 2500/3500 vehicles. In vehicles equipped with the Duramax diesel 6.6 liter engine and the optional engine-block heater cord, a short-circuit condition may develop in the engine-block heater cable or in the terminals that connect the heater cable to the block heater.

Remedy

Dealers will replace engine block heaters and heater cords in cold weather areas using pre-shipped parts. Dealers are to continue to perform the engine block disable procedure on inventory only vehicles and for customers that request disabling because replacement parts are not

yet available. Customers may decline disabling but should be advised to NOT use the block heater system until the system is replaced. Vehicles that have this feature disabled as a remedy to the safety condition will be contacted and offered replacement block heaters and heater cords under a separate customer satisfaction program. Chevrolet Silverado and GMC Sierra 2500/3500 vehicles included in recall 19V328 will be closed under that recall number and addressed under this recall campaign. For this population of vehicles, the heater cord will also be replaced and rerouted by the dealer to address chafing or damage due to improper routing, use, or storage of the existing heating
