AC Generator / AC Generator / Check oil, coolant. Air filter missing, borrowed from another unit.
 Remove front panels.
 Find E-stop wires and connect them
 Connect load bank cables to main breaker box.
 Swap fitting on regulator and connect NG supply line.
 Install ball valve inside enclosure for NG bleed.
 Start unit and let it run through warm up cycle.
 Confirm oil pressure and battery charging.
 Once up to temp, put under load, work up to 80% for an hour. Anything over 80% load would cause it to go down on under frequency.
 Also seems to be a supply fuel problem as it is the same across all units.
 Take off load and let unit cool down, then shut down.
 Bleed off NG and remove supply line and fitting.
 Disconnect load bank cables, remove toggle switch, and put panel back together.

 Batteries swollen, should replace
 E-stop broken
 Remove excess wiring
 Cold start aids recommended for winter
 Air filters missing
