Recall Description

Some vehicles may have been built with an outboard steering linkage jam nut that could loosen allowing one end of the drag link to separate from the adjuster sleeve.

Remedy

Inspect the torque values. If the torque values meet requirement, the nuts will be welded to the adjuster sleeve. If the torque values do not

meet requirement, the drag link assembly will be replaced.

The tailgate actuator limiter tab within the power lock actuator control assembly may fracture allowing the lock rod control bracket to overtravel which may pull the lock rods and release the latches, potentially resulting in the tailgate inadvertently falling open at any time.
