



Transfer of Coverage Application

Mechanical Breakdown Insurance (MBI) and Vehicle Service Contract (VSC)

Please note the following conditions:

- (a) The Policy/Contract cannot be transferred if the vehicle was traded to a dealership.
- (b) The Policy/Contract may only be transferred once.
- (c) **This Vehicle will be ineligible for transfer if used for the following:**
 - i. If *Your Vehicle* is used for business travel with more than one driver;
 - ii. If *Your Vehicle* is used for commercial activity, including but not limited to, rental vehicles, limousines, tow vehicles, job site activity vehicles, hauling vehicles, police or emergency use vehicles, courier/delivery vehicles, driving school vehicles, snow removal vehicles, oil field use vehicles, road repair operation vehicles, racing or competitive driving vehicles, route work vehicles, any vehicle that is used to transfer equipment, or people and taxis;
 - iii. Operation of *Your Vehicle* on the following surfaces: off-road, logging roads, oilfield roads and adjacent sites, and any other locations, which, at the sole discretion of the Administrator, do not constitute a publicly traveled thoroughfare (Coverage is limited solely to vehicles using publicly maintained roads);
 - iv. If *Your Vehicle* is registered outside of Canada;
 - v. If the Original *Warranty* has ever been voided on *Your Vehicle* by the Manufacturer;
 - vi. If this *Vehicle* has ever been deemed a total loss or write off;
 - vii. If the *Vehicle* odometer has stopped, been changed, or altered. (Please review Original Owner's maintenance documents).
- (d) The EBR/GPR Option is non-transferable, and the EBR/GPR Option Fee is non-refundable.
- (e) If the Original Policy/Contract Holder financed the Policy/Contract, they must provide evidence from the Lienholder verifying to the Administrator the payout of the lien.
- (f) You need to obtain maintenance documents from the Original Owner; should you be required to verify proper maintenance at time of claim.
- (g) The Policy/Contract is not cancellable or eligible for any further refund once the Policy/Contract has been transferred.

This application may be denied or voided if any of the above is applicable at any time during the Policy/Contract term.
