BYD Motors Inc. ("BYD") warrants that each new truck manufactured and/or distributed by BYD shall be free, under normal use and with proper maintenance, from defects in material or workmanship (Full Coverage). The Warranty period is detailed below.

## LO-WARRANTY PERIOD FOR BATTERY

The lithium iron phosphate battery (FE battery) is warranted to charge and discharge normally and have a remaining apacity of 65% or greater by the end of ten (10) years or 0,000 hours, whichever comes first
