Labour	Complaint: OIL LEAK NEAR FRONT STRUCTURE; Cause: Customer request; Correction: The job began with the standard procedure: draining the engine oil, coolant, and A/C refrigerant. Next, the alternator wires were disconnected, along with the engine harness and the A/C hose from the compressor. The belt tensioner and accessory bracket were unbolted, followed by the side brackets on both sides of the cylinder head. The air compressor's mounting bolts were removed, the top radiator hose came off, and attention turned to the front of the engine.

The front cover and valve cover were removed to gain access to the timing area. The engine was then pinned in place for safety and precision. The balancer plate and front engine seal came off, as well as the lower front cover.

With the engine open, the Jake brake harness was disconnected, and the rocker shafts on both camshafts were removed. That's when a major issue was found: the injector camshaft showed heavy pitting on cylinder #2. To investigate further, the cam gears were pulled off using a gear puller, and the cam plates were removed. The rest of the front gears and hubs were taken out after that.

Underneath the engine, the oil pan was dropped. Then the front engine mount nuts and bolts were loosened and removed using a 3/4" air impact gun. The steer axle was lifted, jack stands were placed under the engine block, and the axle was lowered to the ground. This allowed for removal of the front engine mount bracket and the front housing bolts. Once unbolted, the front housing was pulled off completely.

To prevent contamination, the oil galleys were plugged. The fuel filter housing was backed off, making room to slide the injector camshaft out. With the mechanical work done, it was time to inspect and clean.

Cleaning began on the block side, and that's when a troubling find appeared: deep pitting in the left side corner of the engine block. The front housing was cleaned next, which also revealed deep gasket marks that would need attention. To get better
