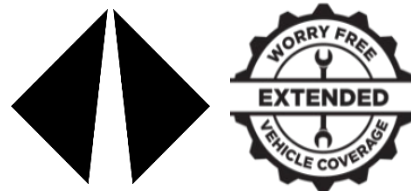


2025 INTERNATIONAL® WORRY-FREE PROGRAM ENGINE & AFTERTREATMENT



SERVICE CONTRACT COVERAGE

This **Engine and Aftertreatment for Heavy Duty/Severe Service** (this “Service Contract”) provides coverage for 24 months or up to 750,000 total odometer miles (1,207,008 total odometer kilometers) traveled per vehicle from the contract purchase date, whichever expiration occurs first. Vehicles with 600,000 miles (965,606.4 total odometer kilometers) or greater traveled per vehicle from the contract purchase date are not eligible for coverage under this Service Contract. For qualified units the coverage under this Service Contract expires at 750,000 total odometer miles (1,207,008 total odometer kilometers) even if prior to the 24-month threshold. Qualified units are outlined by model year and mileage at time of purchase as defined by the contract policy number.

During the period, International Motors, LLC*. (“International”) will repair or replace any of the covered components as defined below which proven defective in material and/or workmanship in normal use, with new or ReNEWed® parts. Exceptions are listed herein under What is Not Covered.

OBTAINING SERVICE

To obtain service under this Service Contract, return this vehicle to any International® truck dealer authorized to service this model vehicle and engine. To locate an authorized dealer near you, please call the International Customer Service Center at 800-44-TRUCK (800-448-7825).

WHAT IS NOT COVERED:**Components / Items:**

- Correction of loose fasteners, squeaks, rattles, and unusual noises.
- Adjustments.
- Items warranted by their respective manufacturers.
- Any part that is not a International or Cummins part number.
- Unauthorized parts other than International service parts or ReNEWed® parts.
- Aftermarket parts or service kits.
- Parts requiring replacement at inspection or adjustment maintenance intervals for reasons other than being defective.

Repairs:

- Vehicles with pre-existing conditions are not eligible for coverage under this program
- Maintenance-related items/ repairs or those as a result of normal wear and tear, including tune-ups, gaskets, belts, seals, lubrication, and/or other similar procedures/parts required to keep vehicle in good working condition. These services include, but are not limited to: oil changes, oil filters, air filters, fuel filters, cleaning/polishing, engine tune-up, adding oils, tightening of air intake and coolant clamps.
- Repairs to any part of the vehicle subjected to misuse, negligence, improper maintenance, improper operation, or which is the result of an accident.
- Seals, wheel seals, gaskets, belts, hoses, and lubricants, except when required in connection with a warrantable failure.
- Attaching accessories, thermostats, flex plate, externally mounted electrical & filtration systems.
- No coverage will be granted if powertrain, driveshaft and Suspension sales guidelines (specifications) are not strictly adhered to by all owners and operators of this vehicle.
- Rust, corrosion, cosmetic issues, bright work.
- Failure to maintain correct maintenance schedule.
- Failures or damage resulting from abuse or neglect as determined by International, which includes, but is not limited to: operation without adequate coolants or lubricants; over speeding; lack of maintenance of lubricating, cooling or intake systems; improper storage, starting, warm- up, run-in or shutdown practices.
- Failures caused by incorrect oil, fuel, or catalytic reagent or by water, dirt or other contaminants in the fuel, oil, or catalytic reagent.
- Accidents, acts of nature or other events beyond control the of International.

Other:

- Engines sold and/or operated outside the United States and Canada.
- Engine or Engine components which have had unauthorized alterations or modifications.
- Engines on which the odometer reading has been altered.
- Incidental, special, indirect, or consequential costs or expenses which the owner may incur as a result of a malfunction or failure covered by this warranty, such as vehicle damage, communication expenses, meals, lodging, overtime, loss of use of engine or vehicle (“downtime”), loss of time, inconvenience, cargo loss or damage, and other similar costs and expenses.
- Replacement of defective parts which were not authorized International equipment when first installed
- Towing, unless additionally purchased.
