



#### **Recall Description**

CORROSION OF THE FRONT BRAKE ROTORS MAY CAUSE SEPARATION OF THE ROTOR DISC FROM THE CENTER HUB (HAT) SECTION. THIS CONDITION RESULTS FROM OPERATING THE VEHICLE FOR EXTENDED PERIODS IN GEOGRAPHIC AREAS USING LARGE AMOUNTS OF ROAD SALT FOR SNOW AND ICE REMOVAL.

#### Remedy

REPLACE BOTH FRONT BRAKE ROTORS.
