Lessee agrees that lessor shall not be liable for any damage to any property of lessee, or any property upon which the lessee is lawfully in occupation of. Conditions which prevent satisfactory operation of equipment do not relieve lessee of his responsibility for rental charge. Lessee assumes all responsibility for equipment while out of possession of lessor and agrees to return such equipment to the lessor in as good a condition as it was at the effective date of the lease, natural wear and tear from a reasonable use period excepted. All equipment lost or damaged beyond repair will be paid for by the lessee at the new replacement cost and all damaged equipment which may be repaired and the repairs paid for by the lessee. Accrued rental charges cannot be applied against the purchase price or cost of repairs of such damages or lost equipment. All transportation charges must be borne by the lessee. Rental begins when equipment leaves the lessor's yard and continues until returned thereto. This lease is made and shall be effective when the equipment is delivered to the lessee or the carrier.
