#3 AXLE WHEEL SEALS. FURTHER DIAGNOSES IN ORDER TO DETERMINE ALL THIS IS REQUIRED. QUOTED WORST CASE SCENARIO

#2 LEFT BRAKES LOOK WET, BRAKE POT IS BROKEN AND WILL ALSO NEED FURTHER DIAGNOSES. QUOTED WORST CASE

REMOVED BRAKE DRUMS AND RE-INSPECTED TO CONFIRM BRAKE PARTS THAT ARE NEEDED, INFORMED PARTS AND SERVICE,

LIFTED TRUCK AND REMOVED WHEEL ENDS. FOUND THAT #2 INNER TIRE ON LEFT SIDE TO BE COMPLETELY FLAT AND RIM WAS SEIZED. FOUND SUBSTANTIAL AIR LEAK SO HAD TO RUN AIR DIRECTLY TO TANK TO RELEASE BRAKES TO TURN WHEELS AND BACK OFF SLACKS. CLEANED #3R AND #3L HUBS AND DRUM. RE-ASSEMBLED. FOUND DAMAGED STUD NUT ON #3 RIGHT AND REPLACED. FOUND THAT #3L AXLE SHAFT SEIZED TO HUB, TOOK ADDITIONAL TIME TO FREE. CLEANED BEARINGS (INSPECTION FOUND GOOD) AND RE-INSTALLED WITH NEW AXLE GASKETS. ALSO REMOVED #2 L WHEEL AND DRUM AND RE-INSTALLED (HAD TO INSPECT FOR BRAKE STYLE AND FOR LEAKS).

FOUND #3L DRUM HEAVILY CONTAMINATED BY OILS AND BRAKE DUSTS, TOOK TO PRESSURE WASHER TO CLEAN - TOOK ADDITIONAL TIME TO CLEAN. CLEANED #2L HUB AND DRUM AT PRESSURE WASHER, SPRAYED HUB WITH BRAKE CLEAN TO AVOID RUST WHILE SITTING.

INSTALLED CLEANED HUB AND AXLE SHAFT.

FOUND DAMAGED AIR LINE REPLACED AIR LINE.

REPLACED A FITTING TO BRAKE POT, ADJUSTED BRAKES, REPLACED TANK DRAIN VALVE. CHECKED DIFF OILS AND ADJUSTED
