DEF dosing unit leaking DEF through electrical connector. CAUSE

DEF suction/backflow/supply lines are cracked, melted, leaking and pinched.

Decomposition reactor DEF dosing valve mounting threads damaged, severely rusted, broken bolt.

DEF tank gouged

for fault codes, multiple active ATS fault codes present, resembling a failed DEF dosing unit. Removed DEF dosing unit protective cover and inspected electrical connector, there is a large deposit of crystallized DEF on the exterior of the connector. Disconnected and removed OEM ATS DEF tank/dosing unit harness from DEF dosing unit, DEF is flowing from the dosing unit. The dosing unit has failed and has caused contamination of the OEM ATS DEF tank/dosing unit harness in the process, both must be replaced. Performed inspection to determine extent of damage to aftertreatment system. DEF test strip shows no contamination and urea mixture at 32.5%, within specification. Found the DEF tank suction and backflow lines were severely heat stressed and cracked, they must be replaced. The DEF dosing valve pressure line is pinched and must be replaced. The DEF tank vent fitting is broken, and there are deep gouges in the bottom of the DEF tank, it must be replaced. During attempt to remove and inspect the DEF dosing valve, the bolts broke off in the decomposition reactor which is severely rusted, recommend replacement of the decomposition reactor. Used inspection camera to check for crystallized DEF deposits in the decomposition reactor, none present. Noted the engine ECM calibration revision is CA90008.23 and the most recent revision available is CA90008.42, and includes numerous updates and improvements, recommend it is installed. Due to the number of initial failures found, additional

diagnostics may be required after the repairs and verification steps are performed.
