LIST: - PLATE LIGHT NOT WORKING. FOUND LIGHT ASSEMBLY FAULTY. REPLACE LAMP AND WIRE IN. - STEERING SHAFT U JOINT AT BOX WORN OUT. DISCONNECT THE SHAFT AT THE BOX AND THE COLUMN IN THE CAB THEN REMOVE IT FROM THE CHASSIS. PUT THE SHAFT IN A VISE, REMOVE THE SNAP RINGS AND THEN THE U JOINT. CLEAN UP THE YOKES AND INSTALL A NEW JOINT. REINSTALL THE SHAFT AND GREASE THE U JOINTS. - MULTIPLE AIR LEAKS ON THE FIREWALL BRAKES APPLIED AND RELEASED. AIR UP THE SYSTEM AND INSPECTED FOR AIR LEAKS WITH THE PARK BRAKES RELEASED. FOUND MULTIPLE FITTINGS LEAKING. REMOVE THE LINES AND REPLACE THE FITTINGS. CHARGE THE SYSTEM AGAIN AND INSPECT FOR LEAKS WITH THE SERVICE BRAKE APPLIED. AGAIN, FOUND MULTIPLE LEAKING FITTINGS THAT WE REPLACED. CHARGED THE SYSTEM AGAIN AND VERIFIED NO FURTHER LEAKS. SOME OF THE FITTINGS WERE A FIGHT TO GET THE LINES AND FITTINGS DISCONNECTED. - #1 RIGHT SHOCK LOOSE, BUSHINGS WORN. REPLACE THE SHOCK - #2L S-CAM BUSHINGS POUNDED OUT AND BRAKES WORN. JACK UP AND SUPPORT #2 RIGHT, REMOVE THE WHEELS, DRUM, LININGS, AND ANCHOR PINS. THE ANCHOR PINS WERE SEIZED. REMOVE THE SLACK FROM THE S-CAM WHICH WAS ALSO SEIZED AND TOOK SOME TIME TO REMOVE WITHOUT DAMAGING IT. UNBOLT THE
