Loosened off all six injector fuel supply lines and hold downs on injectors. Used heel bar to lift injectors out of cylinder head. Cleaned up injector bores and cylinder head. Installed 6 new injectors and torqued to spec. 30nm plus 90 degrees. Installed injector housing and valve cover. Hooked up with Davie and set all 6 injector trim codes. Flashed ECM to latest update and cleared all faults. Primed fuel system and got engine running. Started at stopped a handful of times and engine starts right away. Took unit for a good road test. No further codes. Engine runs good. (Has a bad tick customer is aware of)Setup fuel system for the injector leakage test to measure
