Correction	-Drained coolant. -Drained engine oil. -Removed oil filter adapter. -Removed oil cooler. -Removed starter. -Removed transmission and transfer case. -Removed lower and upper oil pans. *Found rear main engine seal leaking. -Replaced rear main engine seal. *Had to find all the pieces for the seal remover and installer. *Had to remove an old seal from the remover. *Had to repair the seal remover (the threads were galled, damaged and distorted. Lots of filing was required with both a standard flat file and thread files). *Had to find parts to jig the seal remover as part of the remover is missing and could not be found. -Cleaned and resealed upper oil pan. -Replaced lower oil pan. -Reassembled vehicle. -Filled engine with oil (used the 13 liters the customer provided. Engine is still about 1 liter low.
