Performed E338 fuel injector replacement recall. Checked PCI software level; NA226 was loaded. Pack 2-style injectors were already installed.

Performed the normal injector replacement procedure. No upfitting was required. Removed the air box and upper and lower valve covers to perform the repair. Removed all six injectors and fuel transfer tubes. Cleaned the injector bores. Installed new injectors with new hold-down bolts. Torqued the injectors and fuel transfer tubes to specification. Reinstalled the valve covers with new gaskets and reinstalled the air box. Primed the fuel system, ran the engine, and inspected for leaks. No leaks were present. Performed injector reset and injector calibration verification; all tests passed. Cleaned the repair area. Injectors were returned for warranty. Session report saved in Tech Data. Recall completed.
