REPAIR NO A/C

- Boost tractor and bring into the shop.
- A/C seems to blow very little cold and not much air movement in the cab from the blower, hooked up the recovery unit and recovered the refrigerant, service manual calls for 5lb refrigerant, tractor only had 2 lbs in.
- Checked and found the evaporator core in roof lining is plugged.
- Removed roof and open evaporator.
- Remove evaporator and washed out with water and air until no more dirt comes out.
- Reinstalled evaporator and resealed the box.
- Found the roof is cracked at the left rear corner, when handling the roof it cracks even more.
- Fabbed a small bracket and drill holes in roof to clamp the crack shut.
- Install roof and sealed up the unused bolt holes with silicone.
- Evacuate and recharged the system with 5lbs of refrigerant as needed.
- Ran the A/C system and checked to ensure proper operation.
