General Motors has decided that a defect which relates to motor vehicle safety exists in certain 2003-2023 Chevrolet Express Cutaway and GMC Savana Cutaway incomplete vehicles. These vehicles are equipped with an unused circuit that a final-stage manufacturer may elect to use to install an optional rear HVAC system.

Remedy

The rear HVAC blower motor circuit(s) at the left side B-pillar will be properly sealed to prevent moisture exposure.
