May 16 BA- Brought machine into shop then got all filters brought out to me. I started to change all of them, only have two filters left.

May 19 JC2- Disassembled and assessed boom pin cylinder, piston is marked up. Ordered new pin assembly, while waiting cleaned up mating surfaces. Tacked plate back onto oil pan, installed a bead of RTV onto engine oil pan. Installed onto machine and torqued into place, drained coolant and refilled cooling system.

May 19 BA- Replaced cam sensor due to external leak.

May 19 CM1- Drained engine oil, removed front drive shaft and oil pan. Cleaned gasket on block and pan

May 20 JP2- Assisted Jessie with broken pin in piston

May 20 JC2- Drained and changed differential oils, installed covers on LH side of engine. Filled engine with oil, started machine and positioned boom so that bucket cylinder can be removed. Removed bucket cylinder, placed bucket cylinder into press. Removed rod guide and rod assembly, placed rod assembly into press. Removed piston ring, retaining pin and piston. Threads were damaged and rod had chrome damage, will need to be sent to machine shop.

May 22 JC2- Chained up bucket linkage and positioned boom. Removed hydraulic line and retaining hardware for boom pin. Removed boom pin and replaced with new pin. Installed retaining hardware, hydraulic line and all linkage. Tested operation, removed transmission seal and installed new
